

PROGRESS REPORT (For the Period April to September, 2023)

REVIVAL OLD AGE HOME SHIRUI VILLAGE, UKHRUL DISTRICT, MANIPUR

Our organisation i.e Revival Foundation, has been running an old age home at Shirui Junction, Ukhrul District, Manipur since the year 2019-20. The is managed from the own fund of the organization and donations from local youth clubs, well wishers. The home is getting support & co-operation from the village authority, clubs of the village & adjoining villages in running and maintenance of the centre. The inmates are mostly neglected and destitute. The inmates are brought to the Home by the local youths and village authority. The organization provides VTC to the inmates and beneficiaries for their extra income.

A project proposal for 50 bedded Sr. Citizens' Home at Shirui Village, Ukhrul District, Manipur was submitted to The Ministry of Social Justice & Empowerment during the year 2021 as per Ministry's notification for gap districts of Manipur with recommendations from the Government of Manipur.

However, Senior Citizens' Home for 25 beneficiaries only has been approved for financial grant-in-aid by the Ministry of Social Justice and Empowerment under the Scheme of Atal Vayo Abhyuday Yojana (AVYAY) vide letten No. AG-15039/37/2021-Sr.C-1 (E.O.No.41986), dated 15th February, 2023.

During the reporting period i.e from April to September, 2023 an expenditure of Rs. 12,19,630/- was made by means of Temporary borrowing of Rs. 11,58,300/- and Organisation contribution of Rs. 61,330/- respectively. To run and manage the home successfully, the home has a total of 9 (nine) staffs. At present, the home has 25 beneficiaries as permanent beneficiaries of the home as per the scheme of AVYAY and 21 Senior Citizens are given benefit of Day Care service by the organisation.
